Residential Swimming Pool Requirements

The following guidelines have been established to help homeowners and contractors identify what is needed to obtain a building permit for the installation of swimming pools and spas for residential use. A swimming pool is defined by the code as any structure intended for swimming or recreational bathing that contains water over 24 inches (610mm) deep.

An electrical permit is required for the wiring of the filter pump, heater and any accessory lighting. Also it is important to note that all residential electrical contractors must be licensed for residential work in Mahoning County. This is not a State of Ohio electrical license, as that only pertains to commercial installations. All electrical permits are issued through Central Electric Inspection Bureau, (CEIB 330-744-5238).

Commercial swimming pool approvals and permits must be obtained through the Ohio Department of Health; their phone number is: 614-466-1390 and web address: www.odh.ohio.gov

THE FOLLOWING INFORMATION SHALL BE REQUIRED FOR A BUILDING PERMIT TO BE ISSUED:

- SUPPORTING PERMITS: ZONING, SANITARY/ SEPTIC, ELECTRIC, PLUMBING
You must have all applicable supporting permits prior to submitting your application
- MAHONING COUNTY RESIDENTIAL PERMIT APPLICATION
- SITE PLAN; SHOWING: LOT SIZE, HOUSE, POOL AND FENCE WITH ALL DIMENSIONS
- CONSTRUCTION DETAILS OF WORK TO BE COMPLETED, I.E., DECK PLANS, FENCING
- TOTAL PRICE OF CONSTRUCTION; FENCE, DECK, HEATING AND POOL/ SPA INSTALLATION
- A COPY OF MANUFACTURES SPECIFICATIONS FOR INSTALLATION

Once your information is received it will be reviewed by a plans examiner to determine if the proposed project meets code. You will be notified if additional information is required or that the project has been approved, the type of inspections required and that your permit is ready for pickup. Please note: With all of the required information this process can be completed in as little as two to three days.
