

DELINQUENT LAND TAX NOTICE TAX YEAR 2020

The land, lots and parts of lots returned delinquent by the County Treasurer of Mahoning County, with taxes, assessments, interest and penalties charged there-upon agreeable to law, are contained and described in the following list. Notice is hereby given that the whole of such several tracts, lots or parts of lots will be certified for foreclosure by the County Auditor pursuant to law unless the whole of delinquent taxes, assessments, interest, and penalties are paid within one year, or arrangements can be made with the County Treasurer to enter into a payment plan for the payment of delinquent taxes in installments over a period not to exceed five years beginning on the earliest date delinquent taxes that are the subject of the undertaking were included in a certification under section 5721.011 of the Revised Code; however, a person entering into an undertaking may request, and the treasurer shall allow, an undertaking providing for payment in installments of over a period of no fewer than two years beginning on that date. For each undertaking, the County Treasurer shall determine, and shall specify in the undertaking, the number of installments, the amount of each installment and the schedule for payment of the installment under Section 323.31 of the Revised Code. To apply for a payment plan, call the Mahoning County Treasurer Monday through Friday from 8:00 a.m. to 4:30 p.m. at (330) 740-2460. An interest charge will accrue on accounts remaining unpaid after the last day of November unless the taxpayer enters into a written delinquent tax contract to pay such taxes in installments prior to December 1, 2021.

Notice also is hereby given that a Tax Certificate may be offered for sale or may have been sold under section 5721.32 or 5721.33 of the Revised Code with respect to those parcels shown on this list. If a Tax Certificate on a parcel is purchased, the purchaser of the Tax Certificate acquires the state or its taxing district's first lien against the property and an additional interest charge of up to eighteen percent per annum shall be assessed against the parcel. In addition, failure by the owner of the parcel to redeem the Tax Certificate may result in foreclosure proceedings against the parcel. No Tax Certificate shall be offered for sale if the owner of the parcel has either discharged the lien by paying to the Mahoning County Treasurer the amount of delinquent taxes, assessments, penalties, interest, and charges charged against the property, or has entered into a valid undertaking pursuant to section 323.31 of the Revised Code to pay those amounts in installments. Notice is hereby given that any delinquent vacant lands will be certified for foreclosure or foreclosure and forfeiture by the county auditor pursuant to law unless the whole of the delinquent taxes, assessments, interest, and penalties are paid within twenty-eight days after the final publication of this notice.
